#### Introduction

- □ Violation of Exceeding the Standards vs. Probability of Exceedance (超越頻率)
- □ Hazard, Risk, and Disaster/Catastrophe (危害、危機/風險、災害/巨災)
  - ⇒ 危害 Hazard:可能威脅人體健康或人類福祉之現象或事物
  - ⇒ 災害 Disaster: 危害成真者稱之為災害,例如人員傷亡、財產損失等
  - ⇒ 危機/風險 Risk: 危害成為災害之機率與可能損失的組合函數
- ☐ Risk Analysis, Risk Assessment, and Risk Management
- □ Quantitative Assessment, Qualitative Description and Comparative Ranking
- ☐ Health Risks, Environmental/Ecological Risk, and Socio-Economic Risks
- $\Box$  Adaptation of Climate Change: Risk = f (Vulnerability, Exposure, Hazards)





Figure SPM.1 Illustration of the core concepts of the WGII AR5. Risk of climate-related impacts results from the interaction of climate-related hazards (including hazardous events and trends) with the vulnerability and exposure of human and natural systems. Changes in both the climate system (left) and socioeconomic processes including adaptation and mitigation (right) are drivers of hazards, exposure, and vulnerability. ### • RISK ASSESSMENT: FOUR STAGES

□ Hazard Identification 危害確認:包括危害性化學物質種類、危害性化學物質之 毒性(致癌性、包括致畸胎性及生殖能力受損之生殖毒性、生長發育毒性、致突 變性、系統毒性)、危害性化學物質釋放源、危害性化學物質釋放途徑、危害性化 學物質釋放量之確認。

- □ Dose-Response Assessment 劑量效應評估:致癌性危害性化學物質應說明其致癌斜率因子,非致癌性危害性化學物質應說明其參考劑量、基標劑量或參考濃度。
- □ Exposure Assessment 暴露量評估:進行開發活動於營運階段所釋放危害性化學物質經擴散後,經由各種介質及各種暴露途徑進入影響範圍內居民體內之總暴露劑量評估。
- □ Risk Characterization 風險特徵描述:依據前三項之結果加以綜合計算推估,開發活動影響範圍內居民暴露各種危害性化學物質之總致癌及總非致癌風險,總非致癌風險以危害指標表示不得高於1;總致癌風險高於10-6時,開發單位應提出最佳可行風險管理策略,並經本署環境影響評估審查委員會審查。風險估算應進行不確定性分析,並以95%上限值為判定基準值。
